Visions for Creative Housing Solutions, a public charity with the 501c3 designation, has been providing permanent, secure housing to individuals with developmental disabilities and other disabling conditions since 2014. Sunrise Farm, our founding site in Enfield, New Hampshire, now serves 11 residents. In 2021, we expanded into a second location-Green Street Commons, in Lebanon, NHwhere another 11 individuals live in their own apartments. With asneeded 24/7 support, all residents maintain their living spaces and join in evening meals and communal activities. On property in Hanover, generously donated to us by the former nonprofit, Outreach House, a third Visions site is currently under development. Visions Hanover will provide a home to 12 more individuals. When it opens in May of 2024, Visions Hanover will offer studios and shared apartments. The majority of Visions residents maintain paid employment, and all of them volunteer in the community.

2022 has been a joy-filled, busy, challenging year! We celebrated the one-year anniversary of Green Street Commons and our first full year operating two sites. It has been an absolute pleasure to watch Green Street residents form their own mutually supportive community. There are so many wonderful ways that residents from both sites connect and collaborate—by joining hands for collaborative volunteer projects or fun community-based activities like our trip to Circus Smirkus and a whale watch excursion.

Maintaining consistent staffing levels so that each resident receives the support they need has been exciting, as well as challenging. As I hear about the staffing challenges being faced by other service providers, it makes me tremendously grateful for the wonderful staff who support our residents. This year we added a second nurse-trainer and a program manager, who helps us maintain the high standards expected by the state while supporting the excellent work of our house managers. 2022 has been a year of developing the management and administrative structures to best sustain the organization as we continue to grow. As we move into and through 2023, I am excited about the future and making our third site, Visions Hanover, closer to reality.

I am so thankful to our Board of Directors and all the people who stepped up at



the beginning to get Visions off the ground. We had no idea we would develop something that would help so many; not just the people we serve, but those who are using what we have done as a model to develop their own options throughout our region and beyond. We could not have done any of this without your interest and support.

The Board, during its annual retreat, determined that the Visions' 2023 strategic goals will include:

- 1. Provide residents with high quality care and a compassionate community in which they can thrive.
- 2. Enhance the organization's fiscal health, while offering competitive salaries for staff.
- 3. Build Visions' third site in Hanover.
- 4. Maintain the key cultural elements of Visions as it expands from two sites to three.

Visions continues to provide a unique and successful model for providing a safe, permanent, and stimulating residential community for a very special population of Upper Valley adult citizens.

Sunrise Farm residents were thrilled to host their first public Open House since 2019. Everyone thoroughly enjoyed sharing the joy and pride clearly evident during that event. During the summer, residents welcomed friends from Green Street to enjoy the inground pool and to explore the hiking trails nearby. And, as always, birthday and holiday celebrations throughout the year brought friends and family members together to share what life is like at Visions in this safe, rural environment.



Green Street Commons residents have all thoroughly enjoyed easy access to Colburn Park for summer performances and the Farmer's Market. They enjoy walking to Lebanon Opera House, AVA Gallery, the Lebanon Library, and nearby bus transportation for work and shopping. They hosted a fun evening of trick-or-treat and games for neighborhood residents, a one-year anniversary celebration for friends and families, and each resident has thoroughly enjoyed the opportunity for independence and adventure inherent in the process of establishing their own homes within a mutually supportive community of friends. As one parent has said, "my daughter has attained a level of independence and sense of purpose greatly exceeding what I had previously expected."



FINANCIAL HIGHLIGHTS—OPERATIONS

Visions has four main sources of operating funds: public sources (72%), resident room & board (11%), grants & donations (10%), and other revenue (7%). Seventy nine percent of these funds go directly to program services, with the balance going to program administration (17%), and fundraising (4%).

As is true for many employers and households, the Visions Operating Fund experienced challenges in 2022. These were related to the cost of wages, food, utilities, and general household goods for each site. By remaining fully staffed and continuing our commitment to paying a living wage with benefits, we continued to offer high quality services. The cost to do that rose, however, and significantly exceeded state fee reimbursement levels. We also had more than one resident in transition during the year, leading to a decrease in billable hours. All together that led to an end-of-year deficit and renewed commitment to diversifying our funding sources in 2023.

ENDOWMENT

In honor of founding Executive Director Sylvia Kluge Dow's 65th birthday, an anonymous donor contributed \$65,000 to establish an endowment. The Visions Board of Directors is establishing guidelines and structure for that funding. Our efforts to build that endowment will begin in earnest after the completion of the Hanover Capital Campaign.



HANOVER CAPITAL CAMPAIGN

The Hanover Capital Campaign successfully raised \$3,157,170 this year, clearly demonstrating our community's commitment to ensuring high quality care for adults with developmental and similar disabilities. This amount exceeded our initial campaign goal of \$2.4m, however supply chain challenges and the cost of goods has risen significantly enough that final bids for the project almost doubled the projected cost, to the \$4,487,224 amount noted above.

Once complete, Visions Hanover — now projected to open in mid-2024 — will be a fully accessible permanent residence for 12 adults with developmental and similar disabilities. As 2023 began, the Hanover Capital Campaign Committee looks forward to launching the public phase of the campaign and raising the remaining amount needed to complete the project.

GIVING BACK...

Visions residents contributed 822 hours of their time as volunteers for other community organizations and activities this year. All residents are encouraged to "give back" and in 2022 100% of residents participated in these efforts. They collaborated with other advocates from around the state to raise money for Best Buddies by participating in their annual Friendship Walk. Other group volunteer efforts included helping veterans at the DV Farm in Gilsum, NH and roadside cleanup efforts during town Green-Up Day events. The organizations that Visions residents supported with their volunteer efforts in 2022 included Road to Independence, the Lebanon Library, Aurora Bakery, and both the Canaan and Lebanon Listen Centers. On a more personal level, residents also helped with dog walking for staff and residents.
